



Privacy Statement

Finance Market is strongly committed to protecting your privacy while interacting with our company, products and services. We want to provide a safe and secure environment for you.

The purpose of this Privacy Policy is to tell you the kind of information we may gather about you when you visit our site, how we may use that information, whether we disclose it to anyone, the choices you have regarding our use of, and your ability to correct this information. Our policy allows you to choose what kind and how much information you provide to us and to control how we use whatever information you give us. Our goal is to provide you with a satisfying experience while allowing you to control your privacy and to give you a means to voice any questions or concerns you may have. This policy applies only to Finance Market and not to other companies' or organisations' websites to which Finance Market is linked.

Collection of information

Information is collected from you primarily to make it easier and more rewarding for you to use our services. Depending on the service you are accessing, you could be asked to provide information such as your name, your company contact details, email address, billing address, bank account details or credit card number in order to provide that service or product to you or information about your likes and dislikes. It is entirely your choice whether to respond to these questions or not.

Use of anonymous information

Finance Market automatically gathers anonymous information to monitor the use of the Finance Market website like the numbers and frequency of visitors very much like television ratings that tell the networks how many people tuned in to a program. We only use such data in the aggregate. This collective data helps us determine to what extent our audiences use parts of the site so we can improve our website to assure that it is as appealing as we can make it for as many users as possible. Finance Market may publish or provide this aggregate data to other people.

Use of personal information

Finance Market will only use the personal information you have chosen to provide us for the purpose for which you provided it. Finance Market will not use it for any other purpose without your consent.

Disclosure

There will be occasions where it will be necessary for Finance Market to disclose your personal information to third parties. Finance Market may be required by law to disclose the information or may be required to disclose your personal information to third parties to provide the service you have requested. However, the disclosure will only be made where it is necessary to fulfil the purpose for which you disclosed your personal information. Otherwise than stated above, we do not disclose personal information that you may give us, such as your name, address, email address or telephone number, to any organisation or person outside Finance Market unless you have authorised us to do so. For example, when you contribute to an online forum you may want to publish your name and email address.
